The Images may continue to be exploited beyond the five (5) year period mentioned above, for a term of thirty (30) years, but only insofar as they are used within the framework of retrospective displays exclusively in connection with the DANONE ECOSYSTEM FUND.

I confirm that I am fully entitled to grant to DANONE ECOSYSTEM FUND the hereby authorisation and that I am not bound by any obligation which may limit or be of any hindrance to such right of use.

DANONE ECOSYSTEM FUND may assign the benefit of this authorization, in whole or in part, to third parties.

Representations, authorizations and warranties set out herein are granted to DANONE ECOSYSTEM FUND as well as to its assignees.

This authorisation is governed by and construed in accordance with the laws of France. Should any difficulties or dispute arise in connection with this authorisation, I undertake to do my utmost to reach an amicable settlement with DANONE ECOSYSTEM FUND, before submitting it to the relevant court.

I hereby acknowledge and consent to the use and the processing of my personal data (name, surname, address, email address, telephone) and/or my Images, through a database controlled by DANONE ECOSYSTEM FUND, for the use of the Images described above. I authorize DANONE ECOSYSTEM FUND to transfer such data to its subsidiaries, affiliates or assignees for the same purpose, some of which may be located outside the European Union.
